BRIEFS AND OPINIONS – Oregon Supreme Court and Court of Appeals – The Collection contains unofficial, redacted, copies of Oregon Supreme Court (SC) and Court of Appeals (COA) Briefs and Opinions. This collection does not include confidential and restricted case types. Briefs coverage begins approximately March 2005, continuing to the present. COA Briefs start with 198 Or App 599; SC Briefs start with 342 Or 1.

Decisions of the Oregon Supreme Court, Court of Appeals, and Tax Court are posted weekly as issued by the courts. Each decision is paginated as it will appear in the printed Advance Sheets. Online decisions include citations and hyperlinks to cases dating back to 1998.

PHYSICAL COLLECTION – The State Of Oregon Law Library has an extensive physical collection of legal research materials open to the public. This includes a rare book collection (semi-closed, browsing allowed). Within the library you can access legal databases such as Westlaw, Lexis Advance, HeinOnline, as well as the Oregon eCourt system. You can search the collection [here](#).
