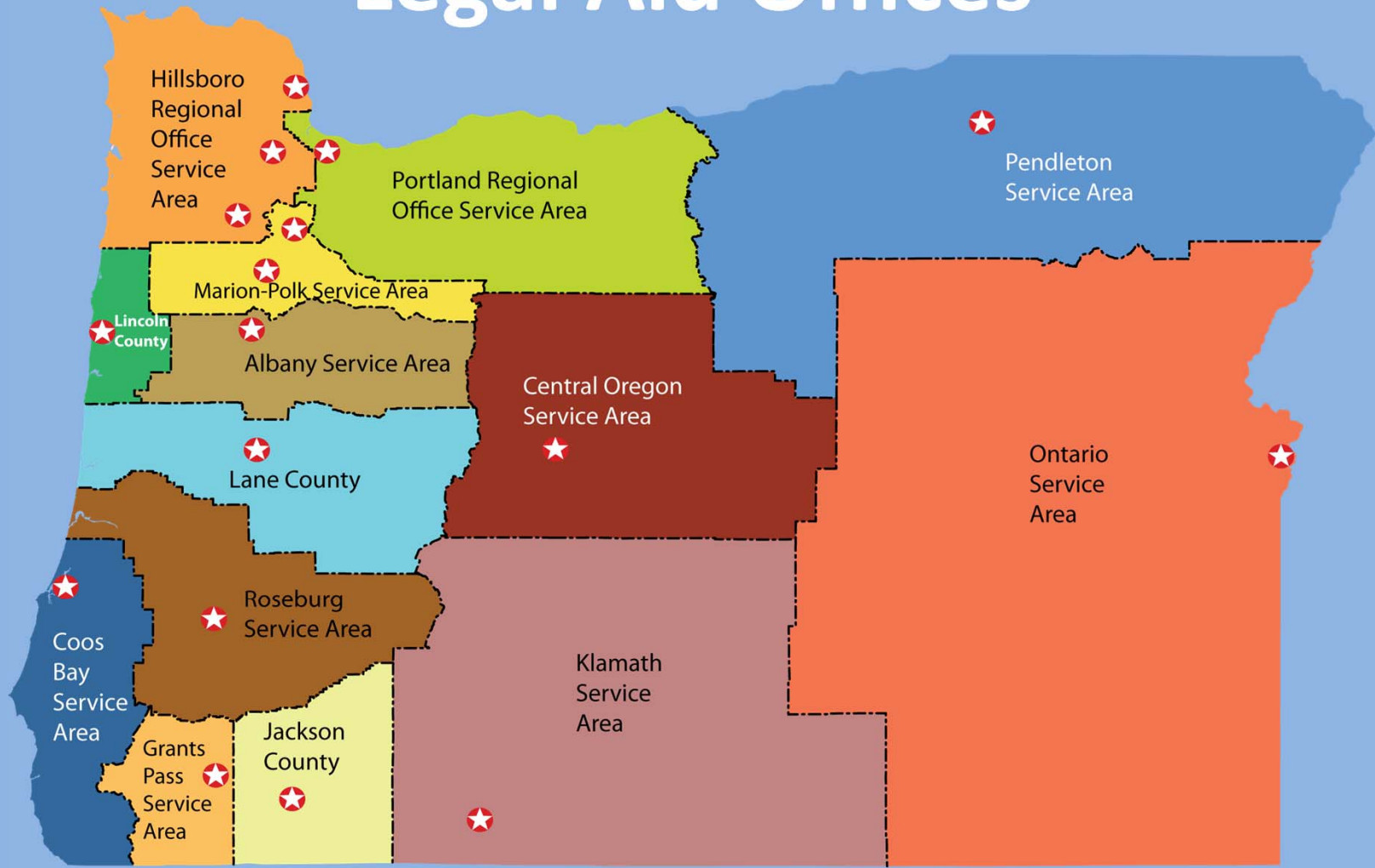

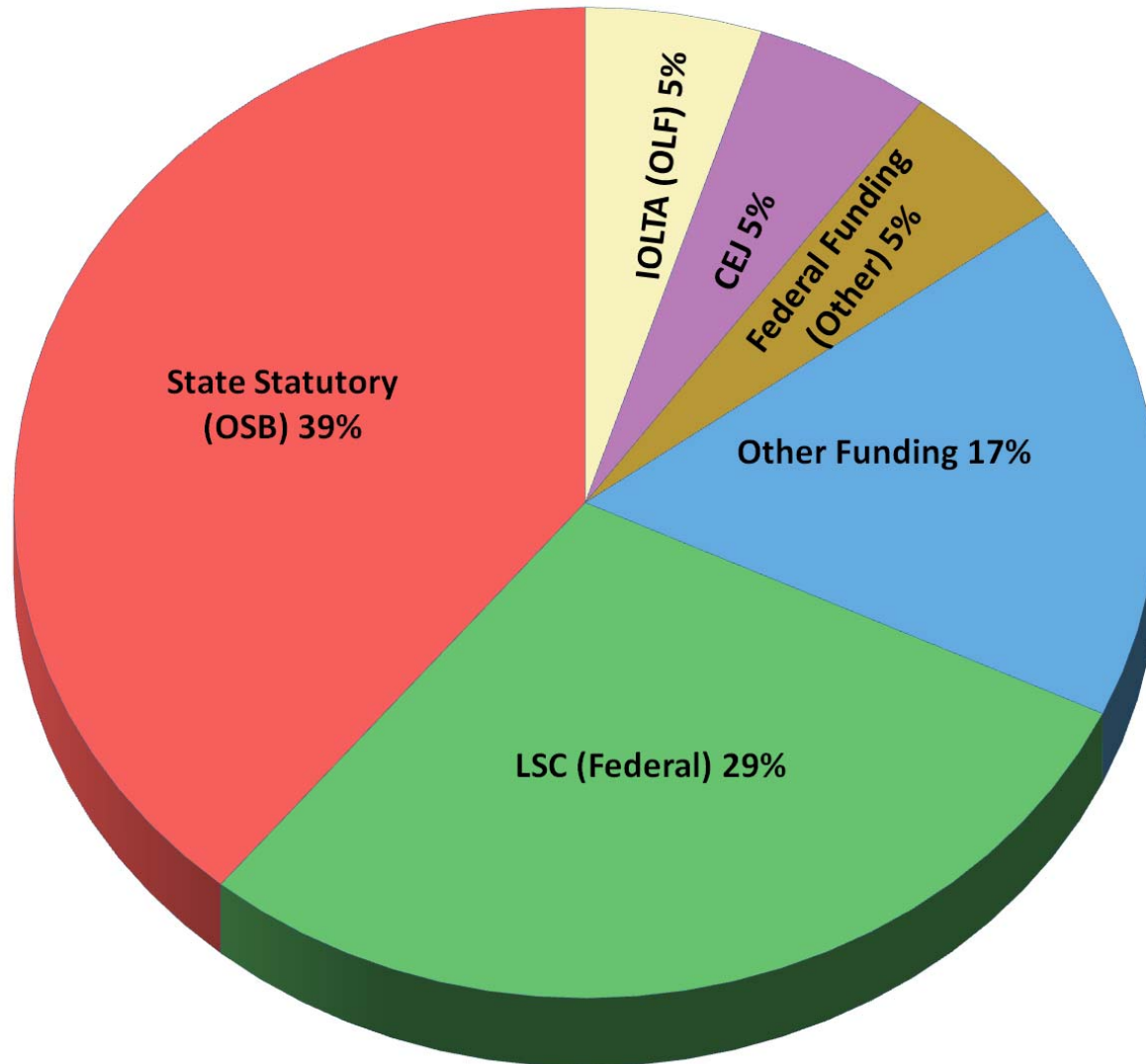

4	\$30,375 per year \$2,531 per month

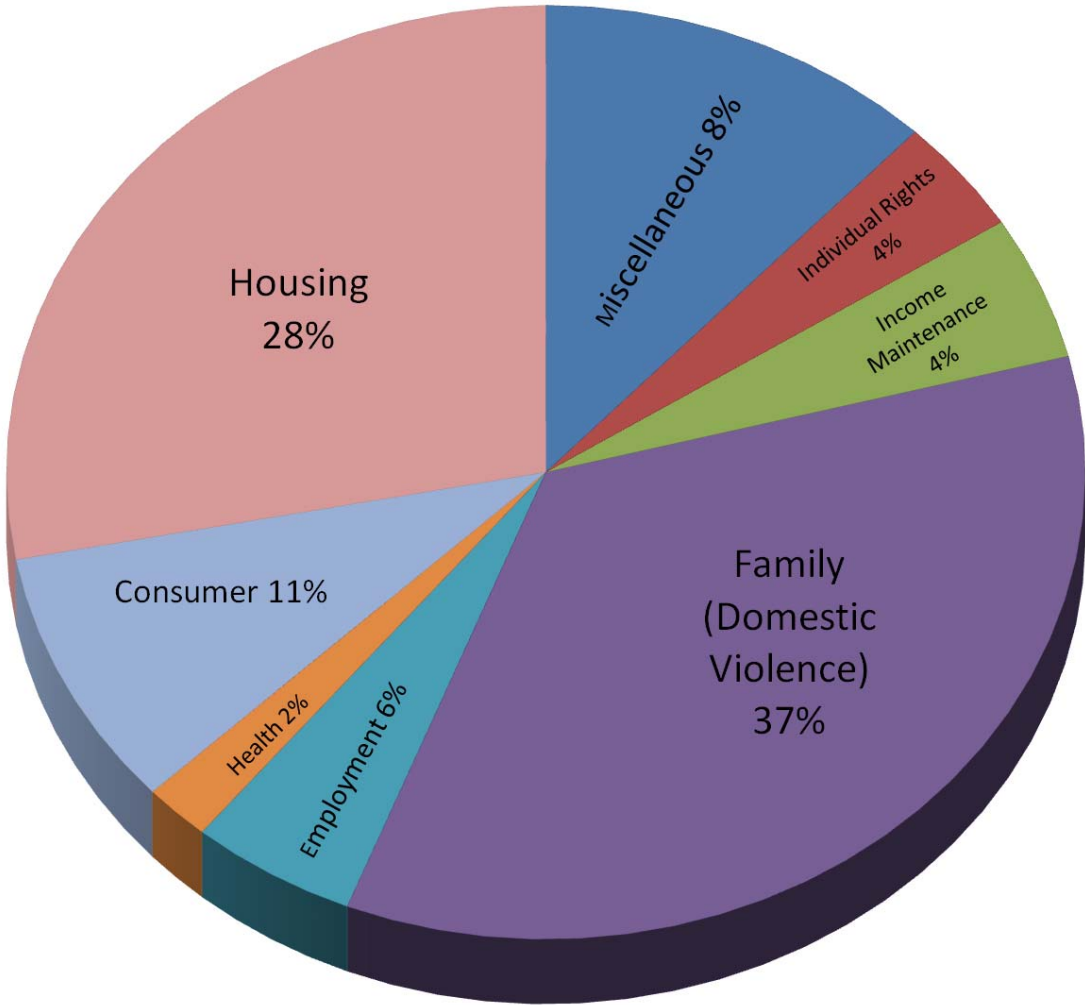
